DISCUSSION ITEMS AND MOTIONS:

Chuck Lowe appeared before the board with a demolition permit to remove a trailer and cabin from Map R15/Lot 4. The board reviewed and approved the permit.

Kevin has scheduled clearing along the fence line at the closed Randolph Landfill. Kevin and Chuck will be clearing trees and brush to avoid damage to the existing fence.

John Turner noted, Raycrest Drive is developing ruts and may need to be graded again. Kevin will take the town's rock rake and go over Raycrest Drive the next wet day to limit the dust.

Michele Cormier stated that resident Brandy Capozello is interested in becoming third member to represent Randolph at AVRRDD. John Turner made a motion to appoint Brandy Capozello as a member to the AVRRDD. Michele Cormier seconded the motion. All Agreed.

Michele, Paul Jadis, and Brandy will be attending the monthly meeting scheduled for Thursday, June 28<sup>th</sup> at the AVRRDD office in Berlin.

Michele Cormier spoke to Dennis Thompson and hopes to reschedule the culvert replacement for Durand Road to the week of July 9<sup>th</sup>. The project is projected to take only 4 days.

The board requested Linda Dupont to send a letter to a resident on Durand Road regarding the removal of a temporary driveway that has been in place since 2017.

Michele Cormier motioned to adjourn at 8 PM. All agreed.
