For registration re-newels please completely fill out the information requested on the reverse side of this form, place in a <u>sealed</u> envelope and either drop off at the mailbox at the front door of the town hall, email the form to the town clerk at <u>Townclerk@randolph.nh.gov</u> or regular mail to

2. Once the town clerk has received and reviewed your information she will notify you either by return letter, email or phone call of the amount of the registration fee(s) that are due to the town and if you have chosen to do so to the state of NH also.

4. Once the check has been received by the town clerk, she will complete the processing of your registration document(s) and return them to you via regular mail at the address you have provided.
